FINAL ORDER

The Petitioner, Yvette Emmanuel, filed a Petition for Hearing (Petition) with the State Board of Administration of Florida (SBA) on February 15, 2026. Petitioner was enrolled in the Florida Retirement System Investment Plan. The SBA denied her request for a distribution as her Investment Plan account funds had already been distributed to her in 2005. On February 18, 2026, the SBA referred the petition for hearing to the Division of Administrative Hearings to conduct an evidentiary hearing.

On February 22, 2026, Petitioner communicated to the SBA's counsel that she wanted to dismiss her Petition. The SBA thereafter provided Petitioner with a draft motion to relinquish jurisdiction, and Petitioner confirmed that she did not oppose the motion.

The SBA filed Respondent's Unopposed Motion to Relinquish Jurisdiction on February 24, 2026. The Administrative Law Judge granted the motion in an Order Granting Respondent's Unopposed Motion to Relinquish Jurisdiction on February 25, 2026.

Therefore, Petitioner's Petition for Hearing is hereby DISMISSED.


