FINAL ORDER

The Petitioner, Amber Peterson, filed a Petition for Hearing (Petition) with the State Board of Administration of Florida (SBA) on October 27, 2024. Petitioner is currently enrolled in the Florida Retirement System Investment Plan. The SBA denied her request to be moved to the Florida Retirement System Pension Plan (Pension Plan). On October 31, 2024, the SBA referred the petition for hearing to the Division of Administrative Hearings to conduct an evidentiary hearing.

On November 4, 2024, Petitioner communicated to the SBA's counsel that she no longer wishes to petition to switch plans to the Pension Plan. The SBA thereafter provided Petitioner with a draft motion to relinquish jurisdiction, and Petitioner confirmed that she did not oppose the motion.

The SBA filed Respondent's Unopposed Motion to Relinquish Jurisdiction on November 6, 2024. The Administrative Law Judge granted the motion in an Order Closing File and Relinquishing Jurisdiction on November 6, 2024.

Therefore, Petitioner's October 27, 2024, Petition for Hearing is hereby DISMISSED.
