FINAL ORDER

The Petitioner, Carolina Diez-Infante, filed a Petition for Hearing (Petition) with the State Board of Administration of Florida (SBA) on October 21, 2004. Petitioner is currently enrolled in the Florida Retirement System Investment Plan. The SBA denied her request to be moved to the Florida Retirement System Pension Plan (Pension Plan). On November 6, 2024, the SBA referred the petition for hearing to the Division of Administrative Hearings to conduct an evidentiary hearing.


On January 17, 2024, Petitioner communicated to the SBA's counsel that she wants to dismiss her Petition. The SBA thereafter provided Petitioner with a draft motion to relinquish jurisdiction, and Petitioner confirmed that she did not oppose the motion.

The SBA filed Respondent's Unopposed Motion to Relinquish Jurisdiction on January 17, 2025. The Administrative Law Judge granted the motion in an Order Closing File and Relinquishing Jurisdiction on January 21, 2025.

Therefore, Petitioner's October 21, 2024, Petition for Hearing is hereby DISMISSED.

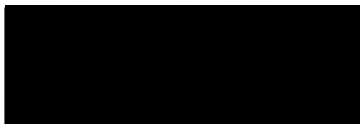


