RECOMMENDED ORDER OF DISMISSAL

THIS MATTER came before the undersigned presiding officer on the Motion to Dismiss filed by Respondent, State Board of Administration ("SBA"). After having reviewed the motion and heard argument of the parties at a duly-noticed telephonic hearing on February 22, 2012, I recommend that the petition be dismissed for the following reasons:

- The petition alleges that the SBA violated a divorce agreement executed by Mr. 1. Tony and his former wife.
- An amended Qualified Domestic Relations Order Concerning a Pension Account 2. with the Florida Retirement System Pension Plan (FRS Pension Plan)("QDRO") was issued by Circuit Court Judge Robert W. Hodges on November 16, 2011. Mr. Nakis contends that the QDRO violates the Joint Stipulation and Property Settlement Agreement he entered into on November 5, 2008 with his ex-wife, which was approved by the circuit court having jurisdiction over their divorce action.
 - Paragraph 10 of the November 16, 2011 QDRO issued by Judge Hodges provides in pertinent part that "...this court expressly reserves jurisdiction over the dissolution proceeding involving the member, the alternate payee, and the member's interest in the Plan." Accordingly,

the jurisdiction to correct any error in the QDRO and to determine whether the distribution to the alternate payee comports with the Joint Stipulation and Property Settlement Agreement remains in the circuit court.

RECOMMENDATION

Based on the foregoing, it is hereby RECOMMENDED, that the Respondent, State Board of Administration, enter a final order dismissing the Petition filed by Nakis Tony, without prejudice to refiling should Petitioner become aware of facts indicating that Respondent SBA did not accurately implement the provisions of the QDRO of November 16, 2011, which does not appear to be the case based on the allegations of the Petition currently before me.
