FINAL ORDER OF DISMISSAL

On June 23, 2017, the Presiding Officer submitted her Recommended Order of Dismissal to the State Board of Administration (“SBA”) in this proceeding. The parties jointly moved for dismissal with prejudice on the grounds that the Petitioner, Gregory Harris, wished to withdraw his Petition that contested the SBA’s forfeiture proceeding. Petitioner, Gregory Harris, was entitled to, and did receive, his employee contributions as provided pursuant to Section 112.3173, Florida Statutes. A copy of the Recommended Order of Dismissal is attached hereto as Exhibit A. The matter is now pending before the Chief of Defined Contribution Programs for final agency action.

ORDERED

The Recommended Order (Exhibit A) is hereby adopted in its entirety. The Petitioner’s petition for hearing hereby is dismissed with prejudice.

Any party to this proceeding has the right to seek judicial review of the Final Order pursuant to Section 120.68, Florida Statutes, by the filing of a Notice of Appeal

pursuant to Rule 9.110, Florida Rules of Appellate Procedure, with the Clerk of the State Board of Administration in the Office of the General Counsel, State Board of Administration, 1801 Hermitage Boulevard, Suite 100, Tallahassee, Florida, 32308, and by filing a copy of the Notice of Appeal accompanied by the applicable filing fees with the appropriate District Court of Appeal. The Notice of Appeal must be filed within thirty (30) days from the date the Final Order is filed with the Clerk of the State Board of Administration.




