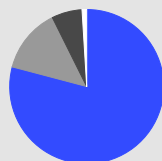

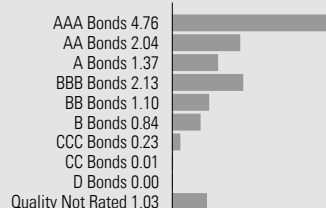

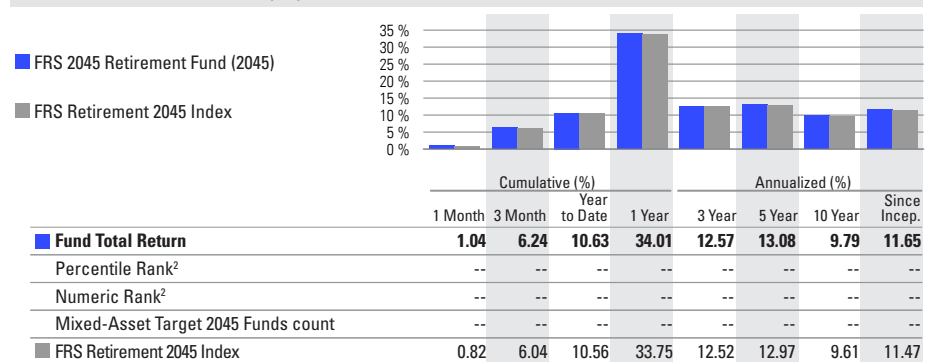

Credit Quality (%) as of 06/30/21



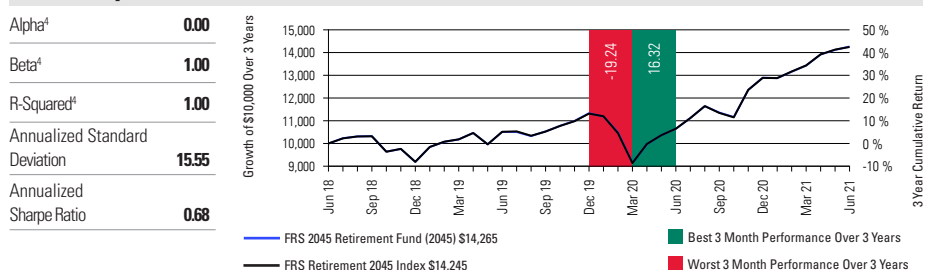
Historical Performance (%)

Risk Analysis (3 Year)

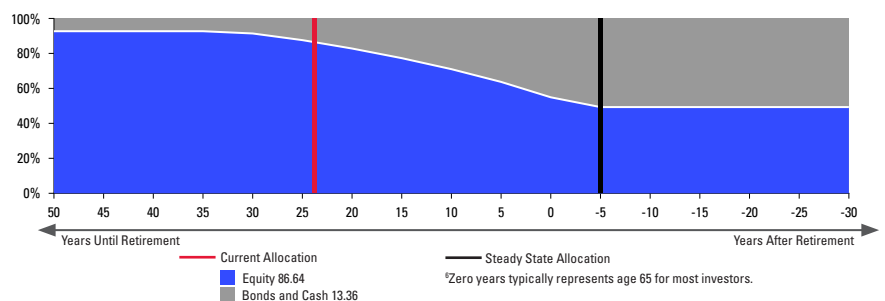

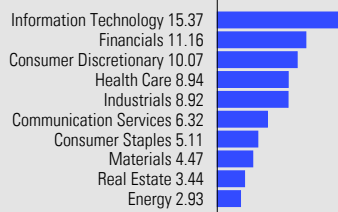

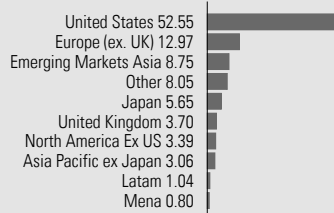
